The general public will be allowed to purchase tickets, which they will then exchange at the booth of their choice in return for a sample of that team’s barbeque or hash. At the conclusion of the event, teams may then turn in any tickets they have collected for reimbursement of \$.75 per ticket. The general public will be allowed to vote for their favorite entry and trophies will be awarded.

Vending Fee: Any team wanting to sell food must pay a vending fee of \$100 and meet requirements of SC Department of Health

***Anything Goes:** Your recipe must incorporate at least one of the following Carolina Pride products: pork tenderloin, thick sliced bacon and/or country sausage. The product will be provided (up to 2 different products) and will be available on Friday, July 9th. Entry should fit in standard 9” x 9” box .
