



Code of Conduct

The City of Greenwood (hereinafter referred to as "City") strives to provide and maintain inviting facilities where individuals feel welcomed and valued. To promote orderly conduct and to help protect City staff, patrons and property, the City has established behavior regulations for the Uptown Market, a City property located at parcel ID# 645-812-957.

Behavioral regulations will be enforced by City staff or designee in a fair and reasonable manner. Parents and caregivers, not City staff, are responsible for the actions and safety of children visiting the Uptown Market. City staff and/or law enforcement officers are authorized to stop prohibited activities and behaviors.

Any individual's failure to comply with the City's established regulations and policies may result in an individual's restricted use of City property, including exclusion from Uptown Market for the remainder of the day or permanent exclusion and/or arrest/prosecution. Any individual excluded from City property may appeal in writing to the City Manager.

Any behavior that is disruptive to the general population; violations of Federal, State, or local laws; and violations of City policy are prohibited. Examples of prohibited activities and behaviors include, but are not limited to:

- 1. Possessing, consuming, or being under the influence of illegal drugs.
- 2. Possessing, consuming, or being under the influence of alcohol unless during a permitted event.
- 3. Engaging in sexual activity of any kind or prolonged display of affection in a sexual manner.
- 4. Threatening to commit or committing acts of violence.
- 5. Displaying material inconsistent with the City's Computer Use and Internet Access Policy.
- 6. Possessing weapons or other items deemed by City staff or law enforcement officers as potentially dangerous to others.
- 7. Intentionally damaging, destroying, or stealing any property belonging to the City, patrons, or staff.
- 8. Failing to heed requests of City staff in relation to potential Code of Conduct violations or other City business.
- 9. Removing, altering, relocating, or misusing City furnishings.
- 10. Using obscene or abusive language or engaging in obscene/intimidating actions.
- 11. Urinating or defecating on City property other than proper use of the restroom facilities.
- 12. Creating disruptive noises such as screaming, loud music or banging on City furnishings.
- 13. Interfering in any way with the free movement of others.
- 14. Persistent staring or following others around on City property.
- 15. Attempting to enter nonpublic areas of the City.
- 16. Smoking or using tobacco products, e-cigarettes or vaping.
- 17. Creating an obstruction for others on entering or exiting buildings or while on City property.
- 18. Skateboarding, rollerblading, using a hover board, running or skating on City grounds or bicycling on plazas or sidewalks designated for pedestrian traffic only. Running may be approved for athletic events obtaining the proper event permit.
- 19. Panhandling, begging, or selling and/or soliciting for services, money, or products without a proper license or permit.
- 20. Sleeping.
- 21. Littering.
- 22. Using photographic, video, or other recording devices to record children without express permission from the child's parent or custodian.
- 23. Entering a City facility without proper attire, footwear and a shirt, pants, or other covering of the upper and lower body. Carried children are exempt from the footwear requirement. Swimwear is required to use the Uptown Market fountain.
- 24. Misusing public restrooms. Bathing, shaving, or lingering is prohibited.
- 25. Adults lingering in the vicinity of children when unaccompanied by children.
- 26. Caregivers leaving children under 11 years of age unattended or in the care of someone less than 15 years old. Caregivers must remain in the same area as the child being cared for.
- 27. Registered sex offenders are prohibited from the Uptown Market area during fountain operation and from events centered around children's activities.
- 28. Having pets in unauthorized areas, failing to clean up after pets, unrestrained pets, or pets that cause a disturbance or safety concern.
